We are an international research group focused on the ethical landscape nurse leaders navigate in contemporary health care systems. Our interdisciplinary team (Nursing, Nursing Science, Advanced Clinical Practice, Management and Leadership, Sociology) is composed of scholars and practitioners from North America and Europe, dedicated to investigating moral distress and ethical decision-making amongst nurse leaders across various cultural and systemic contexts.

Nurse leaders are challenged by ethical issues across healthcare settings. Our goal is to develop insights that enhance ethical competence and resilience within nursing leadership globally.

#PROJECTS AND METHODS

- Ethnographic Revisit and study of corporate culture change In-depth study of changes in corporate culture, leadership, and institutional excellence within a hospital over a 17-year period.
- Cross-National Analysis of Moral Distress in Nurse Leaders Examination of key elements of moral distress identified by nurse leaders in the USA, Germany, Austria, and Switzerland.
- **Psychometric Evaluation of the Ethical Decision-Making Confidence (EDMC) Scale**


To measure confidence levels in EDM amongst nurse leaders, facilitating cross-cultural and cross-systemic comparisons.


